The renter shall pay any and all reasonable costs necessary to enforce the terms of this contract, including attorney's fees.*
- In the event of premature departure from the unit or unavailability of the unit for any reason, renter shall have no right to claim a refund for the unused time. If, for any reason, the unit is rendered unusable or unavailable during the rental period, Blue Moon shall be obligated only to refund that portion of the rent unused and shall have no further obligation.*
- In case of dispute, renter agrees to submit to arbitration in lieu of other legal remedy.*
- Cancellations made at any time after booking are subject to a MINIMUM \$100 fee and may result in complete forfeiture of funds. The refund, if any, will be based upon the number of nights resold.*
